Terms & Conditions of Use

The SASWH eCampus was made available to the SASWH membership to provide online safety training for the healthcare sector of Saskatchewan.

By accessing the SASWH ECampus you accept and agree to all of the terms and conditions outlined in this agreement. Access includes: visiting, enrolling, purchasing or accessing/viewing course content and details. Failure to follow these terms of use will result in denied access to the SASWH ECampus. All terms within adhere to Canadian law.

General Terms

SASWH reserves the right to change course content found within the eCampus and terms and conditions as they see fit and without warning. Continued use of the SASWH eCampus will be deemed your acceptance of any and all terms of use.

Registration within the SASWH eCampus is defined as: a person who has registered for an account at www.saswh.ca or moodle.saswh.ca with the intent to enroll in provided Online Learning courses.

Enrollment and the licenses required for the material of the course is valid to one person only and cannot be exchanged or shared.

Enrolled users of the SASWH eCampus are defined as: any registered user who has enrolled in a course with the intent of accessing provided material for the purposes outlined in the course description.

Registration and enrollment are limited to G22 members and healthcare providers.

All course material, including testing and evaluations are the property of SASWH and may not be distributed, reproduced, shared or modified in any way without the consent of SASWH.

Privacy

SASWH respects the privacy of it's users. All information submitted or provided to SASWH via the website or the eCampus will be used to communicate with our members. For example but not limited to the following; distribution of newsletter, industry and OH&S updates, legislation changes, upcoming events, training and services offered by SASWH. Information will also be used to determine specific privileges and granted access to areas of the website based on need.

There will be circumstances where your name and marks from the eCampus will be shared with a manager or supervisor in your facility. This will be done in a confidential manner in order to help facilitate proper and legislated workplace safety record keeping practices for employers.

All submitted contact information will not be sold, or distributed to third parties without the expressed and written consent of the individual.

SASWH is not responsible for any contact information that may have been submitted via our website by your representative or a 3rd party that didn't have your prior consent for submission.

Access and Availability of eCourses and Content

SASWH strives to maintain updated and current course content for all users of the SASWH eCampus. SASWH reserves the right to change, amend or discontinue any and all courses and course content as it sees fit. Proper notification of changes will be made at the time of participant access to the changed materials.

SASWH takes all reasonable efforts to ensure the uninterrupted access to the eCampus. Notification of cancelled enrollment must be forwarded to learning@saswh.ca. The enrolled user and their records will then be removed from that course ("unenrolled"); but they will remain a registered user of the eCampus for future training.
